Ensure communication of Origin and Quality from bean to cup with Safe Trace Café!



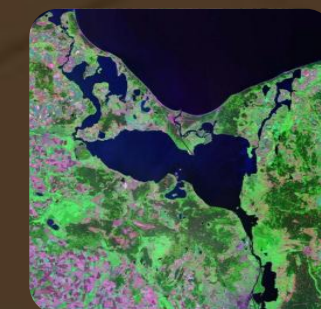

The Conecta Café platform offers data that promotes socio-environmental compliance in production, contributing to sustainability and transparency in the coffee chain.



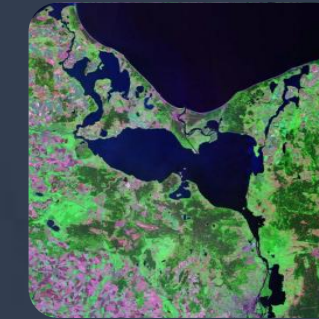
